**Aspen's Bachelor of Science in Nursing (Pre-Licensure) program is the only program offered by Aspen that has the potential to allow graduates to apply for professional licensure in the following states: Arizona, Florida, Georgia, Texas and Tennessee. Upon completion of their studies in this program, students are eligible to take the National Council Licensure Examination (NCLEX) in the state in which they choose to practice (the NCLEX is the national registered nurse examination used by all states for potential registered nursing licensure) and submit an application for licensure. Students provide their state board of nursing applicable forms to the School of Nursing and Health Sciences, which completes them on behalf of the individual student, and take the exam in the state in which they choose to practice. Upon passing the NCLEX, students then work with their state Board of Nursing to secure their professional licensure, including requirements beyond educational background and NCLEX passage.

Licensure/Certification Disclosures
